## ACCOMPLISHMENT REPORT FOR 2017

For the year 2017, once again, the Office of the Sangguniang Bayan which is composed of the Municipal Vice Mayor as the Presiding Officer, Honorable members of the Sangguniang Bayan, the Secretary to the Sanggunian and legislative staff, had efficiently exercised duties, functions and responsibilities in accordance with the Local Government Code of 1991.

The office focused on adopting legislative measures for the effective and efficient administration of the municipality and on formulating local policies that will generate and maximize the resources of the municipality for its priority programs with particular attention on the delivery of basic services to the people and for the progress of Benito Soliven.

Through harmonious efforts and unified actions of the Municipal Mayor, various departments and members of the Sanggunian thru the leadership of the Municipal Vice Mayor, the municipality was able to uphold its continued growth and development through realization of enacted ordinances, and approved functional resolutions that are necessary in the advancement of every family in the municipality.

For the period covering January 1 to December 31, 2017, the Sangguniang Bayan conducted 49 regular sessions, 5 special sessions and 47 committee hearings and meetings. Barangay visitations and consultations were also conducted regularly all throughout the year. As such, the Sangguniang Bayan approved 18 ordinances of which 6 were appropriation ordinances and 120 resolutions.
